



Maryland Lottery® My Lottery Rewards™ Multiplier Family of Games 2nd Chance Promotion Drawing Rules

OVERVIEW:

Beginning any time on Monday, January 20, 2020, until 11:59:59 PM Eastern Time (“ET”) on Monday, May 18, 2020, players can enter the Multiplier Family of Games 2nd Chance Promotion (“Promotion”) offered by the Maryland State Lottery and Gaming Control Agency (“Lottery” or “Maryland Lottery”) for a chance to win cash prizes of \$40,000, \$20,000, \$10,000, \$5,000 or \$2,500. The Lottery will conduct a series of three (3) 2nd Chance Drawings (“Drawings” or “Drawing”) throughout the Promotion to select a total of seventeen (17) winners to win an estimated total of \$135,000 in cash. See below for more information. This is a My Lottery Rewards™ 2nd Chance Promotion.

HOW TO PARTICIPATE:

To participate, enter at mdlottery.com/multiplier, through My Lottery Rewards (“MLR”) at mdlottery.com/rewards, or through the MLR App any non-winning Maryland Lottery® Multiplier Family of Games scratch-off ticket (#465 5X The Cash, #466 10X The Cash, #467 20X The Cash, 468 50X The Cash) and/or any other ticket specified by the Lottery (collectively, “Tickets”; singular “Ticket”). The number of entries received into the Promotion for a submitted Ticket equals the multiplier of the Ticket, i.e., the \$1, 5X The Cash Ticket equals five (5) entries; the \$2, 10X The Cash Ticket equals ten (10) entries; the \$5, 20X The Cash Ticket equals twenty (20) entries; and the \$10, 50X The Cash Ticket equals fifty (50) entries.

For each Drawing: Entries must be entered for a specific Drawing by 11:59:59 PM Eastern Time on the announced Drawing Entry Deadline date to be eligible for that Drawing. (In these Rules, all times are Eastern Time.) Entries are cumulative. Once an entry is submitted, it will remain in the pool of entries unless selected as a winning entry. **See the Drawing Chart below for Drawing Number, Drawing Entry Deadlines, Drawing Dates, Number of Winners, Prizes, and Claiming Deadlines.**

A Drawing may include any random selection event. These are bonus Drawings, and the prizes are bonus prizes.

Internet access and a valid email address are required for you to enter this Promotion and its Drawings. Mailed entries will not be accepted. Winners in each Drawing will be drawn starting with the highest prize value first, followed by the next highest, etc. You may enter as often as you like; however:

- You may win more than once throughout the Promotion;
- You may win only once per Drawing; and
- Only one winner per residence address is allowed per drawing.

You do not need to keep your original ticket in order to claim your prize if you win. (Players and winners are sometimes referred to as “you” and “your”.) A qualifying entry is one (1) Ticket. A Ticket may only be used to enter one time. The number of entries per Ticket is equal to the multiplier number of the Ticket.

To enter and to win, you must be 18 years of age or older.

All winners, including alternate winners (“Alternates”), must claim your prize by 4:30 PM on the respective claiming deadline dates shown above.

PRIZE DESCRIPTION:

\$40,000

One (1) winner will be selected to receive a cash prize of \$40,000 in the form of a check.

\$20,000

One (1) winner will be selected to receive a cash prize of \$20,000 in the form of a check.

\$10,000

Three (3) winners, one (1) winner per Drawing, will be selected to each receive a cash prize of \$10,000 in the form of a check.

\$5,000

Six (6) winners, two (2) winners per Drawing, will be selected to each receive a cash prize of \$5,000 in the form of a check.

\$2,500 Cash:

Six (6) winners, two (2) winners per Drawing, will be selected to each receive a cash prize of \$2,500 in the form of a check.

CLAIMING:

You will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. Claiming deadlines for winners and Alternates are included in the chart above. All winners must claim your prize in person **by 4:30 PM of the respective Claiming Deadline date** listed in the chart above.

If a winner is disqualified or by the relevant claiming deadline has not claimed, submitted all required documentation, and been confirmed and validated as eligible, then an Alternate may be selected. A decision to replace a winner with an Alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as a winner is no longer entitled to a prize. Alternates must claim by 4:30 PM on the claiming deadline date designated for that Alternate.

Winners must claim your prize as follows (Allow a minimum of 15 business days after the Lottery receives a claim and proof of eligibility for delivery of your prize):

- 1) You must claim your prize in person at the Lottery’s Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.
- 2) Winners must furnish photo I.D. proof of being at least 18 years of age.
- 3) If you win a prize and you owe State Obligations, which include but are not limited to child support and/or certain other obligations to a State agency or other governmental entity, then you must pay those outstanding State Obligations within five (5) days after claiming the prize in order for the prize to be awarded to you. Failure to pay your outstanding State Obligations within five (5) days of claiming the prize will result in the prize being applied to your unpaid State Obligations. If the amount of the prize won exceeds the amount owed, you will receive the excess prize amount. You will be taxed on the value of the cash prize. Further amounts may be owed.
- 4) In the event of a winner’s death or inability to partake of a prize, the Lottery will make a determination about the awarding of the prize. The Lottery’s decision will be final.
- 5) You do not have the option to request or receive a substitute or equivalent prize for any prize.

Winners of the \$40,000, \$20,000, \$10,000, \$5,000 and \$2,500 prizes will each receive a W-2G form from the Maryland Lottery. You will be taxed on those amounts. All winners are responsible for all taxes, including income taxes.
